CONCLUSION

The research purposed to discuss woman struggle in Timothy Shay Arthur's An Angel in Disguise, Little Lizzie, and Coffee vs. Brandy. There are two objectives of this study. The first is to describe woman struggles in the main characters. The second is to figure out the influences of the main characters toward other characters. Moreover, this research is said to be descriptive because it shows the struggle and influences of the main characters in the form of dialogues and narratives. Maggie is the main character in An Angel in Disguise. She suffers from paralyze to find family that loves her unconditionally.
