ABSTRACT

This research aimed to discuss the irony describing childhood and adulthood in Emily Bronte's "Mild the Mist Upon the Hills". This research also had a purpose, that was, to explain the situational irony related to childhood and adulthood and the symbol of childhood and adulthood.

There are two theories that were used in this research. The basic theories were figure of speech and symbol, and the supporting theories werechildhood and adulthood. Meanwhile, the figure of speech that was used by the writer was irony. The approaches that were used in this research were formalistic approach and structural approach.
