





## **ABSTRACT**

**ALEXANDER BRILYANT ANGGER WIJAYA. (2016). THE SYMBOLS DESCRIBING WOMAN'S LOVABLE AMBITION IN ELIZABETH BARRETT BROWNING'S "HOW DO I LOVE THEE?" AND "THE LADY'S YES".**

This research aims to describe (1) symbols describing woman's loveable ambitions used in Elizabeth Barrett Browning's poems "How Do I Love Thee?" and "The Lady's Yes" and (2) the symbols revealing theme of love.

The theories used in the research are conceptual theory related to meanings, theme, and love. Structural approach and formalist approach are chosen to analyze the data. The research is qualitative so that it is automatically descriptive because the data are words not numbers.

The research figures out five symbols that describe woman's loveable ambitions and the symbols revealing the theme of love. The symbols are (1) heart, (2) sun and candle light, (3) Tulip, (4) Camellia, and (5) clasped hands.

Penelitian ini bertujuan untuk mendeskripsikan (1) simbol – simbol yang menggambarkan ambisi dari perempuan untuk dicintai yang digunakan dalam puisi Elizabeth Barrett Browning yang berjudul “How Do I Love Thee?” dan “The Lady’s Yes” dan (2) simbol – simbol yang menyatakan tema kecintaan.

Landasan teori dari penelitian ini adalah teori konseptual perihal makna, symbol, tema dan kecintaan. Pendekatan structural dan pendekatan formalis dipilih untuk menganalisis data. Penelitian ini bersifat kualitatif sehingga secara otomatis bersifat deskriptif karena datanya berupa kata-kata bukan angka.

Penelitian ini menemukan lima simbol yang menggambarkan ambisi dari perempuan untuk dicintai dan simbol – simbol yang menyatakan tema kecintaan. Lima symbol tersebut adalah (1) heart, (2) sun and candle light, (3) Tulip, (4) Camellia, and (5) clasped hands.
