### **CHAPTER I**

#### INTRODUCTION

## 1.1 Background of the Study

Rees (1973: 2) states that literature is a writing which expresses and communicates thought, feeling, and also attitude toward life. While, Jones in *An Outline of Literature* says that literature is simply another way in which we can express and communicate thought, feeling, and attitude toward life through a written language (1968: 1).

Literature can be said as the imagination of feeling that arise lives through experience to fill desires. Nowadays, a lot of people spend their spare time by reading literary work. Literature can be divided into three groups namely drama, prose, and poetry. The researcher uses a novel as the material of analysis. Novel is one of the most interesting and popular forms of literature. It entertains the reader who reads the story. Kettle in *An Introduction to the English Novel* says, "A novel is living thing, all once and continuous, like any other organism, and in proportion as it lives will it be found, I think in each of the parts there is something of the parts" (1951: 12).

The researcher is interested in analyzing Alice Walker's novel entitled *The Color Purple* which was firstly published in 1982. Alice Walker is well known as a novelist, poet and feminist. Walker was born on February 9, 1944, in Eatonton, Georgia. Alice Walker is one of the most admired African-American writers working today. Walker's career as a writer took flight with the publication of her third novel, *The Color Purple*, in 1982. Set in the early 1900s, the novel is explored the female African-American experience through the life and struggles of its narrator, Celie.

The story of Alice Walker's *The Color Purple* tells about an ugly, uneducated, stupid and poor young girl named Celie. She always gets bad treatment from the people surrounding her, especially from her step father who rapes her and her husband who continually hits her. Domestic violence and sexual abuse influence the development of Celie's character. Celie's character development makes Celie's life becomes better. Furthermore, the researcher wants

to analyze more about the development of Celie's character as the main character in Alice Walker's *The Color Purple*.

### 1.2 Statement of the Problem

In the discussion of this thesis, based on the background of the study, there are several problems that will be analyzed. Those are:

- 1. How is Celie characterized in Alice Walker's *The Color Purple*?
- 2. What are the causes of Celie's character development in Alice Walker's *The Color Purple*?
- 3. What are the effects of Celie's character development in Alice Walker's *The Color Purple?*

### 1.3 Objective of the Study
