ABSTRACT

CANDIK PRANOTO (2013). THE COMPARISON OF GOTHIC ELEMENTS IN POE'S *THE MASQUE OF THE RED DEATH* AND *THE FALL OF THE HOUSE OF USHER*.

This study is related to the comparison of gothic elements in Poe's *The Masque of the Red Death* and *The Fall of the House of Usher*. The discussion in this research deals with the similarities and differences of gothic elements, as well as the influences of gothic elements toward the characters in the two short stories.

In this study, the researcher uses the theory of character, characterization, the revenant, the suspense, and the uncanny. Next, sociological and psychological approaches are applied to analyze the data. Moreover, library research including internet browsing is used to find the data of gothic elements.

The findings indicate that both short stories contain gothic elements within them. They are the revenant, the suspense, and the uncanny. Each gothic element in the two stories is different due to their own way. Every single element in the two stories has unique characteristics. The analysis shows that there are some effects that are caused by gothic elements toward the Narrator in *The Fall of the House of Usher* and Prince Prospero in *The Masque of the Red Death*. Those effects are dread, goosebump, rage, and desperation.

ABSTRAK

Penelitian ini berkaitan dengan perbandingan unsur-unsur gotik dalam *The Masque of the Red Death* dan *The Fall of the House of Usher* karya Edgar Allan Poe. Pembahasan pada penelitian ini berkaitan dengan persamaan dan perbedaan unsur-unsur gotik serta pengaruh unsur-unsur gotik terhadap para karakter di dalam kedua cerita tersebut.

Dalam penelitian ini, peneliti menggunakan teori karakter, karakterisasi, mayat hidup, ketegangan, dan gaib. Selanjutnya, pendekatan sosiologis dan psikologis yang diterapkan untuk menganalisis data. Selain itu, penelitian kepustakaan termasuk penelusuran internet digunakan untuk mencari data unsur-unsur gothic.

Temuan pada hasil ini menunjukkan bahwa kedua cerita berisikan unsur-unsur gotik dalam keduanya. unsur-unsur tersebut adalah mayat hidup, ketegangan, dan gaib. Setiap unsur-unsur gotik dalam dua cerita memiliki perbedaan masing-masing. Tiap satu unsur gotik dalam dua cerita memiliki keunikan. Analisis membuktikan bahwa ada beberapa efek yang disebabkan oleh unsur-unsur gotik terhadap Narator dalam *The Fall of the House of Usher* dan Pangeran Prospero dalam *Masque of the Red Death*. Pengaruh-pengaruh tersebut adalah ketakutan, merinding, amarah, dan putus asa.
