





ABSTRACT

YOLANDA ROERI NABILA. (2015). MALE SUPREMACY IN HENRIK IBSEN'S *A DOLL'S HOUSE*.

Madiun: Jurusan Sastra Inggris, Fakultas Sastra, Universitas Katolik Widya Mandala Madiun.

This research discusses male supremacy in Henrik Ibsen's *A Doll's House*. It aims to (1) explain male supremacy conducted by Torvald in the drama and (2) explain the effects of Torvald's male supremacy toward himself and Nora. This is a library research, in which all the data and the theories were taken from written forms including internet browsing. The theories used in this study are the theories of character, characterization, patriarchy, and woman oppression. Moreover, the approaches applied are psychological approaches and sociological approach. The analysis focuses on male supremacy conducted by the main character, Torvald Helmer. Torvald Helmer as a leader on his family has a power to control his family and his wife's life. Torvald Helmer as a husband demands his wife, Nora not only mentally and physically but also financially. In this condition Nora gets oppression and depression that cause her to depend on her husband.

ABSTRAK

Penelitian ini membahas kedudukan tertinggi laki – laki dalam drama *A Doll's House* karya Henrik Ibsen. Tujuan penelitian ini adalah: (1) menjelaskan mengenai kedudukan tertinggi laki – laki yang dilakukan oleh Torvald dan (2) menjelaskan mengenai pengaruh dari kedudukan tertinggi laki – laki Torvald terhadap dirinya dan Nora. Penelitian ini merupakan studi pustaka yang data dan teori – teorinya diambil dari sumber tertulis termasuk data yang diambil dari internet sebagai referensi. Teori yang dipakai dalam penelitian ini mencakup teori tokoh, teori penokohan, teori patriarki dan teori penindasan wanita. Selain itu pendekatan yang diterapkan antara lain pendekatan psikologi dan pendekatan sosial. Analisis penelitian ini berfokus pada kedudukan tertinggi laki – laki yang dilakukan tokoh utama yaitu Torvald Helmer. Torvald Helmer sebagai seorang pemimpin di dalam keluarganya yang memiliki kekuatan penuh untuk mengatur kehidupan keluarganya dan jugaistrinya. Torvald Helmer sebagai seorang suami menuntut istrinya Nora tidak hanya secara fisik dan mental tetapi juga secara finansial. Di dalam kondisi ini Nora mendapatkan penindasan dan depresi yang berakibatkan dia menjadi ketergantungan kepada suaminya.
