ABSTRACT

AR. KEVIN SEAN KEEFE LOUHENAPESSY (2014). SWEAR WORDS USED IN *FAST AND FURIOUS* MOVIE SERIES.

This research focuses on swear words found in *Fast and Furious* Movie Series. The aims of this research are to describe the kinds of swear words, the users of swear words and the purposes of uttering swear words.

Pragmatic equivalent method is used to describe the kinds of swear words, the users of swear words and the purposes of uttering swear words. In getting the data, the researcher used field research. The data were taken from movie series entitled *Fast and Furious*; *The Fast and The Furious* (2001), *2 Fast 2 Furious* (2003), *The Fast and The Furious Tokyo Drift*, *Fast and Furious* (2009), *Fast Five* (2011) and *Furious 6* (2013).

The result of the analysis showed that there were 135 data of swear words based on Hughes's classifications; they were swear words related to sex (20 items), swear words related to excrement (51 items), swear words related to name of animal (13 items), swear words related to personal background (6 items), swear words related to sexual activity (4 items), swear words related to taboo or religion or oath (38 items) and swear words related to mental illness (3 items).

Moreover, the users of swear words are elaborated in the basis of Holmes's classifications. There were two aspects which influence the users of swear words. The first was the users of swear words based on age. It was divided into swear words which were uttered by youngsters (117 items) and swear words which were uttered by old generation (18 items). The second was the users of swear words based on gender and occupation. It was divided into swear words which were uttered by men (121 items) and swear words which were uttered by women (14 items).

Furthermore, the purposes of uttering swear words are categorized based on Eric Partridge's classifications. They were swear words used to express anger (87 items), swear words used to degrade or put down (10 items), swear words used to express a response of shock (3 items), swear words used to express protest (9 items), swear words used to express intimacy (5 items) and the last classification was swear words used to identify a certain profession (21 items).

ABSTRAK

Penelitian ini membahas tentang umpatan-umpatan atau kata-kata hinaan yang diucapkan di dalam serial film berjudul *Fast and Furious*. Tujuan penelitian ini adalah untuk menggambarkan macam-macam umpatan, penutur umpatan dan menentukan tujuan penggunaan umpatan-umpatan tersebut.

Metode pragmatik digunakan untuk menggambarkan macam-macam umpatan, penutur umpatan dan tujuan penggunaannya. Teknik penelitian lapangan digunakan dalam mengumpulkan data. Sumber data penelitian ini adalah film *Fast and Furious; The Fast and The Furious (2001), 2 Fast 2 Furious (2003), The Fast and The Furious Tokyo Drift, Fast and Furious (2009), Fast Five (2011)* dan *Furious 6 (2013)*.

Hasil analisis menunjukkan bahwa terdapat 135 jenis umpatan berdasarkan klasifikasi Hughes, yaitu organ seksual 20 jenis, kotoran atau benda najis 51 jenis, nama hewan 13 jenis, latar belakang individu 6 jenis, kegiatan seksual 4 jenis, kutukan 38 jenis dan sakit mental 3 jenis.

Lebih lanjut, penutur umpatan diuraikan berdasarkan klasifikasi Holmes, yaitu ada 2 aspek yang mempengaruhi penutur umpatan tersebut. Aspek pertama adalah umpatan yang dipengaruhi oleh umur. Dalam hal ini, klasifikasi umur dibagi menjadi umpatan yang dituturkan oleh orang muda, yakni ada 117 data dan generasi tua, yakni ada 18 data. Aspek kedua adalah umpatan yang dipengaruhi oleh jenis kelamin dan peran sosial. Dalam hal ini, klasifikasi jenis kelamin dan jenis kelamin dibagi menjadi umpatan yang dituturkan oleh laki-laki 121 data dan perempuan 14 data.

Selanjutnya, tujuan menggunakan umpatan dikategorikan berdasarkan klasifikasi Eric Partridge yaitu, umpatan yang digunakan untuk menunjukkan kemarahan 87 data, umpatan untuk menganggap rendah seseorang 10 data, umpatan untuk mengekspresikan kekecewaan 3 data, umpatan untuk mengekspresikan protes terdiri atas 9 data, umpatan untuk mengekspresikan intimasi 5 data dan umpatan untuk menyebut pekerjaan orang lain 21 data. Semua umpatan-umpatan di dalam film seri *Fast and Furious* memiliki banyak macam, berbeda penutur dan berbeda penggunaannya.
