CHAPTER I

INTRODUCTION

1.1 Background of the Study

Sometimes, people like to imagine something as if it were real. By reading, people usually imagine the story to catch the message. Reading literary works, for instance, gives them some advantages. It can make their brain try to imagine the setting, character and situation that happened of the story then memorize it. Besides, reading literary works not only can make them know about things that happened but also can make them know about life that they have never known before.

In literature, the author tells his story through the form of writing. In the relation of statement above, Kelley Griffith, Jr. mentions that literature is an expression of individuals who write it (1990:44). Furthermore, the reader imagines the story as if they experience it. Its statement supported by Kennedy in *An Introduction to Fiction, Poetry, and Drama* sthat:

"Novel is a book length story in prose, whose author tries to create the sense that, while we read, we experience actual life. This sense of actuality, which is also found in artful short stories, may be the quality that sets the novel apart from other long prose narratives" (1979:231).

In novel, the readers can find some issues that occur in their life such as crime, racism, materialism, sexism, feminism, and so on. So far, when you read

novel that tell about black people's life, you always find that the story tells about racial discrimination. Black people are always considered as wild and like to do violence. As people know, that Africa-American Literature always talks about racial discrimination. The writer is interested to analyze different issue, that is, crime as the topic of analysis.

The writer reads some novels and is interested in black people's story. The writer chooses *Richard Wright's Native Son* as the source of data. Richard Wright is a new African-American writer after Harlem Renaissance.

"Post World War I, Harlem was an undisputed centre of a complex cultural movement out of which appeared a development of black intellectuals, writers, musicians, actors, and visual artist. Variously, it was Renaisance or Negro Renaisance. It was also an artistic development together with social-politic expression black pride". It means that the literary achievement of African-Americans is one of the most striking literary developments of the post-Civil War era. Furthermore, Wright wants more from African-American writers than Langston Hughes suggested in his essay, "The Negro Artist and the Racial Mountain." For Hughes and other Harlem Renaissance writers, the expectation was to write unfettered about black life. Certainly for his time, this suggestion was innovative. However, Wright sees another purpose for the writer: to work to change unjust social, political and economic areas in American society. Bigger is a young black man who wants to be able to do all the things white people do but he does not have such chance. His ignorance and poverty make him ashamed and he feels afraid especially of humiliation, but he does not want to show his shame or fear. He is especially angry at the white, not only because they are caused of the oppressive conditions to his life but also because they scare and embarrass him. However, he is also often angry at his fellow blacks because they do not want to try to improve their life. After killing Mary, for whose family he works as a chauffeur, he thinks that he has the power to take revenge toward the white and to make them take him seriously. And after meeting Boris Max, his lawyer, Bigger finds, for the first time in his life, that he can release his feelings by talking about them, as well as by acting them out violently. The environment around Bigger Thomas does not give the opportunity to get better life and it makes him feel hopeless. Therefore, that hopelessness can turn him into anger and he will do everything without thinking over. It made the writer interested to analyze Crime conducted by Bigger Thomas.

1.2 Statement of the Problem

The writer finds some problems that occur and are interesting to analyze.

1.4 Limitation of the Study
