CHAPTER I

INTRODUCTION

1.1 Background of the Study

In another word, literature is the expression of human life. The author of the literary work focuses on the situation he or she has seen in the society. While R. J. Rees in *English Literature: An Introduction For Foreign Readers*, Literature is writing which expresses and communicates thoughts feelings, and attitudes toward life (1973: 2).

Literature is divided into three kinds: poetry, fiction, and drama. The writer in this thesis will discuss about drama. Reaske Christopher Russel (1966: 5) in *How to Analyze Drama* says that:

A drama is a work of literature or composition of presenting various actions and dialogues between a grownup of characters.

In other word the story in a drama is described through the actions and dialogue of the characters.

In this thesis the writer chooses Henrik Ibsen's play entitled *The Lady from The Sea*. Ellida's adaptation of new social class. It means the entire obstacle which is faced by Ellida for getting success in adapting with her new social class. Moreover it talks about how Ellida changes her status from lower class into higher class after she marries to a rich doctor whose name is Wangel. Ellida changes her social class through her marriage. Ellida's obstacle and success in adapting with new social class is chosen as the topic of the analysis.

Henrik Ibsen writes *The Lady from The Sea* in 1888. It talks about a woman namely Ellida who gets married to a widower with two daughters. Ellida's marriage to Doctor Wangel gives her a higher status. After her marriage she has all of the facilities; she has a luxurious car, and she can go to a beauty saloon as often as she wants. Her marriage to Doctor Wangel makes her become a real lady. This happiness does not last long; their marriage is disturbed by Wangel daughters, Bolete and Hilda. From the first time, his daughters seem to disagree if their married a woman who has the same age as their. And they will never accept Ellida as the member of the family because she comes from different social class. They think that Ellida is not more than a poor and uneducated woman, who marries their father to get better life and wealth.

The great obstacle for Ellida success is from her self. Ellida still thinks that she and Wangel are different. Ellida comes from pour family, uneducated person, and never socializes with the upper class before, While Wangel is rich and famous man that every body knows him. Ellida does not feel confident with this condition, she thinks that she does not know how to behave as rich woman after she gets married with Wangel.

Finally, Ellida's relatoship with her two step daughters get better. Now, they can get along together as a happy family, although Ellida loves former fiancé, at last she chooses to stay with Wangel and his daughters, Bolette and Hilda.

The writer of this thesis is interested in analyzing Henrik Ibsen's *The Lady From The Sea*, because this drama is famous and it has been performed for many times in many countries such as: England, Norway, America (http://www.certainup.com/ladyfromtheseaphila.html: Thursday, 22 November 2007: 10.45 am). Henrik Ibsen as the author of this drama is also considered as one of the greatest authors in America. Ellida's adaptation of new social class in Henrik Ibsen's *The Lady from The Sea* is chosen as the topic of thesis because it describes about the saruggle of lower class woman to get successful life. Moreover this topic is very interesting and challenging to be analyzed.
