#### **CHAPTER I**

#### INTRODUCTION

## 1.1. The Background of the Problem

One of the interesting things that can make the people's life beautiful is literary work or literature. People can interpret their interpretation based on their feeling, and they will get some messages in the literature. By reading it, the reader can solve the problem in their life, and it can make their life beautiful. Hudson (1965: 10) in *An Introduction to the Study of Literature* says in the following:

Literature is vital record of what men have seen in live what they have experience of it. What they have thought and feel about those aspects of it which have the most immediate and enduring interest for all of us. It is thus fundamentally an expression of the life thought the medium of language.

Escape literature, however, takes away the reader from the real world. Thus life interpretation of the literature much depends on the reader. Holman (1986: 354) says in the following:

Literature is divided into three genres: Drama, prose, and poetry, and the term "Novel" is used in its broadest sense to designate any extended fictional prose narrative. He says, "all novels are representations in fictional narrative of line or experience but the form is itself as protean as life and experience themselves have proved to be."

Out of many literary works in Victorian age, the writer chooses to study Charles Dickens novels entitled *A Christmas Carol*. Jones (1968: 80) says, "Some respects a novel is like short story, expect that is longer. Novel is a long story written in prose." Besides that Long (1964: 561) says, "A novel may be set in the world; it portrays imagined people and events." A good novel takes us into the lives of other people and thereby enlarge our own life. Further more, Long (1964: 562-563) says, "A novel is fictional prose narrative usually too long to read at a single setting." Novels are written in prose.

The writer considers that novel is the most exciting form of literature because through the narrative we know that the characters represent their characterization as the result of action. It means that we can enjoy the story by reading the narrative.

The writer chooses A Christmas Carol because it is one of the most popular novels. It is also an interesting novel that has a simple content to be

understood. At last, A Christmas Carol talks about the supernatural which catch our interest because the action of it influences the structures of the plot. Accordingly, the title given to the research is The Influence of Supernatural in the Plot Development in Charles Dickens' A Christmas Carol.
