## **CHAPTER IV**

## **CONCLUSION**

In this chapter, the writer will give the conclusion of the research. The writer shows that there are three statements of problems discussed by the writer in this thesis. The objectives of this study, entitled *The Revenge of Lavinia in Eugene O'Neill's Mourning Becomes Electra* are: (1) to know Lavinia's revenge, (2) to find out the causes of Lavinia's revenge, (3) to find out the effects of Lavinia's revenge. Library researches including internet browsing are used to form the conceptual models which are used to find the data. The data corpus of this thesis includes all of the words, phrases, clauses, sentence and even discourses, which have relation with the causes of Lavinia's revenge, Lavinia's revenge, and the effects of Lavinia's revenge found in Eugene O'Neill's *Mourning Becomes Electra*.
