CHAPTER I

INTRODUCTION

1.1 Background of the Study

The definition of literature is states by Ress on his book entitled *English Literature for Foreign Readers* is as follows, "Literature is writing with expresses and communicates thoughts, feeling and attitudes toward life" (1973: 2). The nineteenth century in England was one of the heavy activities and dynamic change, of ferment ideas and recruitments social unrest, of great inventiveness and expansion. Moreover, Goodwin (1951: 38) in Nineteenth Century Opinion explains as follows:

The opportunities for the development of their intelligence and tribal skills were severely restricted by what was traditionally considered permissible to women. They were also prejudged rather than fairly judged; and they were condemned to a servitude from which they could never emerge unless granted the opportunity to do so.

Women in the nineteenth century England realized that women have to emancipate herself from the myth of inferiority and to realize her potentialities to the fullest, it brought numerous transformation for the women. There is a women emancipation to achieve the same position as well as men.

Emma is created by Jane Austen in 1969. it presents a story of aspect marriage such as love, status, tolerance, age and relatives, and fade.
