CONCLUSION

The total numbers of the data in this research is 100. The percentages on the use of those data are the following, use as preposition 27 data, use as conjunction 8 data, use as adverbial particle 11 data, use as to infinitive 3 data, use as auxiliary 17 data, use as copular verb 9 data, use as main verb 10 data, use as determiner 7 data, use as pronoun 3 data, using as adverb 5 data.
