

ABSTRACT

This thesis discusses about the social condition in England in the 18th century through the imageries and symbols in William Blake's poems entitled *Holy Thursday*, *The Tyger*, and *The Little Black Boy*. The Imageries in William Blake's three poems that have relation to the social conditions are visual, auditory, tactile, kinaesthetic, and organic imageries.

A library research method is applied during the making of this thesis. The data is the site entitled *Songs of Experience and Songs of Innocence* which is published in 1995 in the world-wide-web (www) in International network (Internet). Secondary data are several literary theories and some historical review.

This thesis utilizes the theory of imageries, symbol, setting, industrial revolution age in England, the upper and the middle class, the working class, and racial discrimination. The review of the British social condition during the Industrial Revolution period is also presented to get a better understanding of the background of the story of the poems. This thesis applies the structural approach since it covers some aspects that are relevant to answer the problem formulation. By utilizing this approach; the writer is able to have a deeper research on the social conditions during the Industrial Revolution period in Britain.

The result of the analysis shows that the social condition of each social class in Britain has affected the upper middle class with the working class, and the black with the white in the poems. The upper middle class society in Britain who endures a good living condition has changed into industrialist. They become tyrant to the working class. Meanwhile, the working class who has been forced to work hard becomes suffering to survive in such a bad condition. While the black and the white hate each other. The white consider that the black are bad in everything. The black become the victim of racial discrimination.

Skripsi ini membahas tentang kondisi sosial yang terjadi di Inggris pada abad ke 18 melalui beberapa imageri dan beberapa simbol yang terdapat dalam puisi - puisi William Blake yang berjudul *Holy Thursday*, *The Tiger*, dan *The Little Black Boy*. Beberapa imageri dalam tiga puisi William Blake yang berhubungan dengan kondisi sosial adalah imageri visual, imageri auditori, imageri tactile, imageri kinaesthetic, dan imageri organic.

Studi pustaka telah digunakan dalam skripsi ini. Data dari skripsi ini adalah situs yang berjudul *Songs of Experience and Songs of Innocence* yang diterbitkan pada tahun 1995 dalam jaringan internasional (internet). Data sekundernya adalah teori - teori kesusastraan, dan beberapa ulasan sejarah.

Skripsi ini menggunakan teori imageri, simbol, seting masa Revolusi Industri di Inggris, kaum atas dan menengah, kaum pekerja, dan diskriminasi ras. Ulasan mengenai keadaan sosial di Inggris juga disertakan guna mendapatkan pemahaman mengenai latar belakang cerita puisi - puisi yang lebih baik. Skripsi ini menggunakan pendekatan struktural karena pendekatan ini memiliki beberapa aspek yang berhubungan untuk menjawab permasalahan yang telah dirumuskan. Dengan menerapkan pendekatan ini penulis mampu melakukan penelitian yang lebih dalam tentang keadaan sosial di Inggris pada masa Revolusi Industri.

Hasil dari penelitian ini menunjukkan bahwa keadaan sosial dari tiap - tiap kelas di Inggris telah mempengaruhi golongan menengah atas dengan kaum pekerja, dan ras kulit hitam dengan ras kulit putih. Kaum menengah atas yang menjalani kehidupan yang baik telah menjadi kaum pengusaha industri. Mereka menjadi otoriter terhadap kaum pekerja. Sementara itu, kaum pekerja menderita karena mereka selalu dipaksa bekerja sangat keras hanya untuk bertahan hidup dari keadaan yang buruk. Sementara orang kulit hitam dengan orang kulit putih saling membenci. Orang kulit putih menganggap bahwa ras orang kulit hitam pastilah buruk segala - galanya. Orang kulit hitam menjadi korban dari adanya diskriminasi ras tersebut.
