CONCLUSION

The objectives of the study are to describe the kinds and the purposes of person deixis used by broadcasters of the radio stations. The person deixis will be discussed pragmatically. It is done by reading some studies that are related to the person deixis, finding the person deixis used by broadcasters of the radio stations, collecting, classifying, and analyzing the data. In connection with the discussion on the problem of the use of person deixis by broadcasters of the radio stations, some conclusion can be drawn.
