CHAPTER V

CONCLUSION

The research entitled *The Analysis of English Sentence Used in Short Message Service* aims to describe the kinds of English Sentence and the structure of English Sentence used in Short Message Service. In the thesis, the researcher uses descriptive method because it is considered as the most appropriate method in relation with the problems of this research. The total number of the kinds and the structures of English Sentence used in short message service is 51 data which are taken from short message service in "English Eve" program of 100.5 Duta Cakrawala Serasi FM Madiun and short message service from the tenth semester student's of English Department of Widya Mandala Madiun University.

The kinds of those English Sentence used in Short Message Service are of four types, there are; declarative sentence (15,7 %), interrogative sentence (25,5 %), imperative sentence (11,8 %), and exclamatory sentence (5,9 %). This study finds that interrogative sentence is more frequently used than the other English Sentence used in short message service.

The structure of English Sentence used in Short Message Service consists of three kinds of structures. They are simple sentence, compound sentence, and elliptical sentence. The structure of simple sentence have three combination of patterns, that is; noun + modal auxiliary (5,9 %), noun + linking verb (13,7 %), noun + verb (9,8 %). The structure of simple sentence are dominated by linking verb.

The structure of compound sentence consists of three patterns with the use of conjunction, that is; $noun + modal \ auxiliary + and + noun + modal \ auxiliary (2,0 %), <math>noun + verb + and + noun + verb (5,9 %), noun + linking verb + but + noun + verb (7,8 %).$ It seems that the structure of compound sentence with conjunction but is more frequently used than the other pattern of compound sentence with conjunction.

The elliptical sentence used in short message service has the patterns, that is: the omission of subject (7,8 %), the omission of subject and verb (9,8 %), the omission of subject and object (3,9 %). It seems that the pattern of elliptical sentence with the omission of subject and verb is more frequently used than the other pattern of elliptical sentence.
