CHAPTER I

INTRODUCTION

1.1 The Background of the Study

Jones (1968: 1) in *Outline of Literature* states, "literature is simply another way we can experience the world around us through our imagination." It means that people can express their idea from their experience that happen in their daily life or their environment and show them in their literary works.

It was adapted in the 16th century by the English language from "Novella", and Italian word use to describe a short tale portraying the incidents and often-amorous intrigues of everyday living.

The novel *The Accidental Office Lady* by Laura J. Kriska has interesting ideas. The novel emphasizes to the gender. Gender is interesting point to be discussed. It is a term used to make differences between man and woman. Brannon (1966:16) in *Gender Psychology Perspectives* says, "Gender is the term used by some researchers to describe the traits and behaviors that are regarded by the culture as appropriate to man and woman. The gender discrimination was so clear in Japan. The women are isolated and discriminated in workplace strongly dominated by men both in terms of number and power. Some researches show that in some factories, there is only one

woman among about 80 men in working place. Although in another workplace there are many working women but their class was still low and under the men position and policy. On the other hand, that discrimination creates the bad effect to the society especially for the woman situation. It creates the women harassment. Therefore, men program should give space to energetic women to oppose men's hegemony concerning with gender ideology, which was already rooted in the women and men's conviction.
