CHAPTER I

INTRODUCTION

1.1The Background of the Study

People usually communicate with one another through language. It does not matter whether it is written or spoken language. By using language, people can convey their ideas or emotions to others. H.A Gleason stated that:

Language operates with two kinds of materials. One of these is sound. Almost any set of noise that the human vocal apparatus can produce is used in some way in some language. The other ideas, social situations meaning. (1955: 2)

1.3 The Objective of the Study
