CHAPTER IV

CONCLUSION

The objectives of the study entitled *Gender study on Nora's rebellion in Henrik Ibsen's A Doll's House* are to (1) analyze Nora's rebellion against gender discrimination in *A Doll's House* (2) describe the effects of Nora's rebellion on the other characters.
