

## CHAPTER V

### CONCLUSION

Ellipsis is omission of the words to avoid unnecessary repetition, but instead, in the whole meaning. Furthermore, there are two types of elliptical processes in English. They are ellipsis with substitution and ellipsis without substitution. Furthermore, there are three kinds of ellipsis. They are nominal ellipsis, verbal ellipsis and clausal ellipsis. The researcher refers to the problems which are stated in the previous chapter. Firstly, the researcher wants to know the kinds of English elliptical constructions used in Graham Greene's *The Living Room*. Secondly, the researcher also intends to know the real sentences from which the English elliptical constructions are derived in Graham Greene's *The Living Room*.

This research uses descriptive method. The populations of this research are words, phrases, clauses which undergo elliptical process obtained from the Graham Greene's *The Living Room*. The total number of the population is 100 sentences.

The data analysis shows that 28 data (28 %) are nominal ellipsis. they include 26 data (26 %) of nominal ellipsis without substitution and 3 data (3 %) of nominal ellipsis with substitution. Next, 19 data (19 %) are verbal ellipsis which include 13 data (13 %) of verbal ellipsis without substitution and 6 data (6 %) of verbal ellipsis with substitution. Furthermore, 53 data (53 %) are clausal ellipsis

which include 49 data (49 %) of clausal ellipsis without substitution and 4 data (4 %) of clausal ellipsis with substitution.
