CHAPTER I

INTRODUCTION

1.1 The Background of the Study

Linguistics as a study of language has developed from time to time. It has developed in British University since about 1960. Linguistics is a branch of language study. Referring to the application, linguistics can be applied into three branches. They are psycholinguistics, etnolinguistics, and sociolinguistics.

Sociolinguistics is one of the fields of language study that involve society. It refers to the application of linguistic study to the solution of practical, educational, and social life of all types in real world aspects such as, age, sex, socioeconomic class membership, regional grouping, and status. They have to do with the focusing of sociolinguistics. Besides, different setting for the using of language results different degrees and types of language learning. It may give effect of the socio-cultural setting in the learner's language and also the relationship between learner and target language community. In 1977, Captain James Cook discovered taboo terms and he gave definition of taboo as anything forbidden to be eaten, made used of, or to be said. The words taboos were known by people all over the world but the origin were still in Polynesia. Nowadays, they are widely used in English speaking world.

Language variation is one of the main topics of discussion in the sociolinguistic study. According to Hudson, language variation is a variety of language as a set of linguistic items with similar social distribution (1980:24). In other words, each of varieties of language is used by the same community in the same social distribution. Every social distribution has its own variety of language. People have different point of view toward language in the society. It depends on social distribution between speakers such as age, socio-economic, and classes or sex and it will be reflected in their language. For example penis is a term used in Great Britain as well as the United States. It may be inappropriate in many situations, but in fact it would not fall into the category of taboo words. This is because it is the proper medical term used for male sex organ. But one can-see the difference sex, social level or nationality of the speakers if looking at the many other names applied to the male genital such as John Thomas, Percy, Stiffy, dick, trouser snake, dong, prick, mutton, joint, Johnson, and so on. As a result, penis becomes respectable anatomical term and appears in textbooks or scientific written, it means that *penis* is not taboo anymore.

To match the communication, speaker and hearer have to get the same intention and interpretation. Furthermore, Trudgill says that when two people do communicate successfully, it is clear that much more is involved than the mapping of internal structure (1984:8).

"That goddamned little shit actor," Ray said.

Taboo term in the example above is *big Willy* which refers to men's genital organ. People in the community create it because they want to create their own term to called penis. That is why, the speech community will understand what is the meaning of *big Willy*. It means that the communication is done successfully.

Nowadays, sociolinguistics is widely used as the field of linguistic study. It is fact that society cannot be separated with language. By studying sociolinguistics, the researcher can understand deeply about any kinds of variety which occurs in society. Taboo terms are very popular and the frequencies of the use are very high in the Candace Bushnell's Sex and the City. It makes the researcher is challenged to analyze it based on the sociolinguistic study. Besides, taboos are very phenomenon to be analyzed because they also deal with semantics when they have to do with the context in which the words are used.

1.2 Statement of the Problem

In line with the topic of discussion in this research, three problems are formulated as follows:

- 1. What are the taboo terms used in Candace Bushnell's Sex and the City?
- 2. What are the purposes of using those taboo terms in Candace Bushnell's Sex and the City?
- 3. Who are the users of the taboo terms in Candace Bushnell's Sex and the City?

1.3 Objective of the Study

Related to the statement of the problem, this study aims to analyze the taboo terms. Hence, the objectives of the study are as follows:
