CHAPTER I

INTRODUCTION

1.1 Background of the Study

Literature is a reaction of the author toward his environment and his period. Actually, there are many opinions about literature. Discrimination itself formally classifying into different groups and according the members of each group distinct, and typically unequal. The criteria of delineating the groups, such as gender, race, or class, determine the kind of discrimination (Houghton Mifflin; 2000).

According to Randall taken from racial discrimination is concerning to the violation of all typical problems in both communities, the Whites and Black, such as; culture, religion, class, etc (http://academic.udayton.edu). Racism has relation with the freedom of right. It means that the development of racism absolutely has to do with how the human things about their freedom of living. The more people cannot control their freedom, the more the discrimination wider. This story based on true story that is experienced of the author. As we know that America has different races belongs to the citizen. The minor community in America is a Negro and this population rapidly grows in certain region that is in Deep South.

According to Clark (1962; 4) in the book of *The Ghetto Game*, racial conflict can be meant below:

Racial Conflicts in the City, race relations have been marked by violence, frustration and widespread suffering. They have been the central factor in a prolonged schism between the two oldest regions of the country. The problem of race has mocked the power of religion in our national life. It is in the light of these facts that the citizens must now dispose their selves to deal with racial problems in the fluid and contradictory environment of the growing city.

Talk about negroes, it has relationship to the slavery, crime and other bad opinion that is coherent, because negroes usually have lower in economic and less of education. It is proved by the quotation taken from the internet, stated by Houghton Mifflin that is:

These differing criteria for assignation of membership in particular races had relatively little to do with biology and far more to do with White supremacy -- the social, geopolitical and economic agendas of dominant Whites' vis-à-vis subordinate Blacks and Native Americans - and racism. At the time, Blacks were valuable commodities as chattel slaves; and Native Americans, whose vast lands were the ultimate target of acquisition in a doctrine of Manifest Destiny, were subjects of marginalization and systematic extermination.

The quotation above gives some information about the problems faced by the Negroes in America. The differentiation of stage and culture has the important value of existences the differentiation. Because of these social and cultural differences, in the Deep South practically full of crime, violating a human right and much horrible problems found. Between the Negroes and the White man has a gap that both two races cannot enter their community easily.

If a White man became a Negro in the Deep South, what adjustment would he have to make? What is it like to experience discrimination based on skin color, something over which one has no control?

How else except by becoming a Negro could a White man hope to learn the truth? The only way I could see the bridge the gap between us was to become a Negro. I decided I would do this.
