CHAPTER 1

INTRODUCTION

1.1 The Background of the Study

Literature is a vital record of what men have seen in life, what they have experience of it, what they have thought and felt about these object of it which have the most immediate and enduring interest for all of us. It is thus fundamentally an expression of life through the medium of language.

Actually people have different interpretation and different way to analyze the meaning in a topic of novel, poetry, short story and drama. Jones (1968:5) says as follows:

Literature then depends on both the reader and the writer. Probably no two readers get exactly the same thoughts and feelings from something they read, because their past experiences have been different. By the same, probably no two writers tell a story in exactly the same way because their styles are different.

It means the readers and the writers have different interpretation to analyze and to create the topic because of the fact that they have different feeling and experience to analyze the purpose. It is thus different for the writers to create the topic because of the different styles.

Literature has many branches such as novel, short story, drama, poetry, and prose. Literature, in its broadest sense, includes all written material such as magazines, newspaper, schoolbooks, and dictionaries. In its narrower sense, literature may be in the form of novels, dramas, short stories and poems.

Furthermore, Jones (1968:80) says, "Some respects a novel is like a short story, except that is longer. Novel is a long story written in prose." On novel there are many kinds of experiences of life can be found. The writer usually makes imaginative characters in their writing. They play their characters in novel, which is written on long page. On novel, main character may have conflicts with another character, with nature, or sometimes with him.

The writer is interested in analyzing Mary Ley's Principles in William Somerset Maugham's *Merry Go Round* based on two reasons. The first is the description of the novel that describes the meaning of life related to people in

marital status that is reflected in Miss Ley's principles. The second is Miss Ley's position as a spinster who always gives her helps for her society. It means that she gets an important role in her society because of her goodness.
