CHAPTER I

INTRODUCTION

1.1 Background of the Study

Literature represents human's expression because it is the result of the creation of man's imagination. In the literary work, human can work or create something that has relationship with literature, used of imagination, thought, ideas, experience of life. He wants to make an experiment and develops the formula in which he makes two potion intended to separate good and evil. Therefore, Dr. Jekyll wants to prove his theory. When he is drinking a potion (kind of drug, chemical medicine), he transforms himself into Edward Hyde that he becomes evil, one of his evil that he murders Sir Denvers Carew. Mr. Hyde is Jekyll's dark side, released from the bonds of conscience and lost into the world by mysterious potion. So far, Dr. Jekyll always acts to be a good person, and always shows good impression in his society. But, he changes again to be evil in the form of Mr. Hyde. Shortly after becoming Hyde, he drinks a second potion and once again becomes Jekyll. From here, the persona of Dr. Jekyll is appearing. Means that, the aim of persona blows Dr. Jekyll's cover. Therefore, for along time

Dr. Jekyll hides his mask that he does not realize, he actually has terrible behavior and bad personality.

The writer is interested in the persona concept of main character Dr. Jekyll. First, Dr. Jekyll has dual nature, the good and the evil spirit within himself and every human being has that dual nature. Second, as a respectable man who has good reputation in his society, he acts in front of the public. This may causes a problem that may lead the person into some conflicts. Third, the story talks about hypocrisy of Dr. Jekyll who occurs in the society. Hypocrisy also happens in our society. However, people often do not realize the good and the evil sides that dominate their life. They cannot separate one of these sides or choose one of these sides such as what Dr. Jekyll does. Basically, the society has the power to determine the behavior called good and evil. When people do bad things in his life, such as killing or stealing, he is called as person who is dominated by his evil side. Meanwhile, his good side dominates him if he gives benefits to others such as giving charity to poor people or helping someone.
