CHAPTER I

INTRODUCTION

1.1 Background of the Study

Language has an important role in human's life, because language is a means to reveal human's ideas, feelings, opinions, or even emotions. In expressing something, language has several meanings. Language in art works is different from language that is used in daily conversation. An author has to describe actions, events, outward feelings, and inward feelings. He or she primarily prefers saying and describing that information more vivid than a scientist does in order to get an aesthetic value. Highly connotative language is always used when the author tries to appeal the emotion to make their ideas acceptable and believable. One who often reads a few of literary works once a week has more language skill; it means he or she is more sensitive to the shade of meaning of words than others who have never done so.

When we read a novel, sometimes we feel difficult in judging or finding out what the meaning of the terms are. We just read and read the novels but do not understand what is behind the story and what the author actually wants to say. The message or several messages are the important part. Authors have certain characteristics in their literary works. The author uses a certain terms to attract the attentions of the readers.

The study of linguistic meaning generally divided into two main fields, that is, semantics and pragmatics. Semantics deals with the literal

meaning of words and the meaning of the way they are combined, which has taken together from the core of meaning, or the starting point from which the whole meaning of a particular utterance is constructed. Pragmatics deals with all the ways in which literal meaning must be refined, enriched, or extended to arrive at an understanding of what a speaker means in uttering a particular expression.

In this thesis the writer will discuss the terms on the novel especially in *Harry Potter and the Philosopher's Stone* by J.K. Rowling semantically. The language in that section has a certain meaning. As we know that words, even sentences sometimes have more than one meanings. Therefore, there are many kinds of meaning, such as connotative and denotative meanings. In using language, it is not always in the form of phrase even a word, but it is regarded as a sentence that has deep meaning, so in this thesis the writer will emphasize on the meaning of magical terms used in J.K. Rowling's *Harry Potter and the Philosopher's Stone*.

Words or phrases have meanings. They may be figurative or literal ones. Matthews (1997: 211) states that literal meaning is the meaning of a sentence or other expression as determined solely by those ascribed to the separate words, etcetera, of which it is composed and to the syntactic relations in which they stand. Meanwhile figurative sense is an extension of a basic or literal meaning. For example, *blossom* has a figurative sense, or is used figuratively; in "She is really blossoming," the basic sense being of plants rather than people.

Beside the meaning of each terms, the writer is interested in discussing the linguistic forms (part of speech). Part of speech have been influenced by concepts from structural linguistics that words in a sentence can be classified based on their form and/or the way their pattern in a sentence. The sentence may be further divided according to the function of each words has in the subject-predicate relationship. Each part of speech has a special use (or part) in the make up of the sentence of which it is a unit.

Term is a small scope of language as a particular expression with a certain purpose of language. The following are some terms that have figurative meaning in this novel; Collecting tin, Muggles, Quidditch, Black eye, A silver cigarette lighter, Grey Tuesday, Feeling Saturday, etcetera.

In this study, the writer chooses *Harry Potter and the Philosopher's Stone* because the novel has powerful imagination, sparkling humor, and cliffhanger actions. This novel presents many plot elements; therefore, it has many characters, settings, events, or attitudes that indicate figurative meaning. Beside that, the writer awares that the language used in a novel is different from our daily conversation or standard language. It makes the writer eager to study more deeply the kinds of meaning of terms and also linguistic forms (part of speech) used in *Harry Potter and the Philosopher's Stone* by J. K. Rowling. Based on that reasons, the topic of the study is entitled "A Study of Meaning of Magical Terms used in J.K. Rowling's *Harry Potter and the Philosopher's Stone*."
