CHAPTER I

INTRODUCTION

1.1 The Background of The Study

Literature is a kind of art. It has many good points and functions. Literature is closely related with human life, because literature is produced by human being as a medium to express the senses and thought in attractive form. It is composed into interesting work bearing pleasure and enjoyment. It also reflects human experiences toward life or as a written expression of human thoughts, feelings, and attitudes toward life. To Edward H. Jones Jr. in *An Outline of Literature* explains that literature is simply another way that we can experience the world around us through our imagination, feeling and thought (1968:1). Plays are meant to be seen on stage, but equally true, reading a play may afford certain advantages. One advantages is that is better to know some master piece by them than never know them at all (X.J.Kennedy, 1966:833).

It is valuable for one to study the great works of George Bernard Shaw. His works has is a study based on the play of George Bernard Shaw. His idea is to reform society from poverty, because poverty is the greatest crime in society. Higgins in *Pygmalion* wants to reform society by educating a woman, Eliza Doolittle, of low class phonetics and social manners so that she will have the same

social manners as those of high classes. Shaw creates delightful characters so that he is successful communicating his idea by entertaining them with this jolay.

The writer chooses a drama *Pygmalion* for this thesis and has formulated the title: The Influences of Eliza Doolittle' Ambition on Her Behavior In George Bernard Shaw's *Pygmalion*. Most of this drama discusses the mental development of a lady, in which, this character comes from low class and from broken family. The story of *Pygmalion* is not a romance, as it would rightly have been called if Professor Higgins and Eliza Doolittle had fallen in love and got married. It is a problem play and the problem goes much deeper than the bare story told in *Pygmalion*.

Different classes of society is very important for a group of people in a certain place to maintain their existance in the world, while up to know still exist in society. According to Beth B. Hess, Elizabeth W. Markson, and Peter J. Stein in Sociology say that:

Socioeconomic system is based on a combination of education, occupation, and economy. There are three levels of society, namely, the high class, middle class. And the low class. Many low classes people are looked down by these of the other classes who usually belong to rich people. The statement can be proved by magazines or newspapers that tell now difficult low classes people live while the higher classes people live in luxury and like to hold great party. The writer wants to relate the above mentioned fact with Eliza Doolittle's condition in *Pygmalion*. We know that family has important role in mental development of a child. The major determinant of a child is creation primarily of her family, especially her parents then the influence of environment is important

too. A child who comes from broken family, from lower class and under pressure in her childhood usually grows up to be a bad temper. Man or woman it is impossible for her to grow up of being a good lady. However, Eliza does not do it. Although, she grows up in bad environment, comes from lower class and from broken family, she still has strong personality and grows up to be a good lady. Eliza's ambition can influence her behavior and change the situation and the condition of her family and her life.

The writer is really impressed by the way Eliza Doolittle's character and action change from time to time, especially her ambition that influence her behavior. Although she has no education like others, she solves all her problems and becomes a good looking lady.
