CHAPTER I INTRODUCTION

1.1 Background of Study

Literature is an expression of human life. The expression may be about idea or opinion. With literature, someone wants to convey his idea to another in written works, such as novel, prose, drama, poetry or any others. In many cases, they are interesting to read. By reading literature, we know about the writer's experience, thought, and imagination.
