CHAPTER I

According to Christopher Russel in How to Analyze Drama explain:

Drama is a work of literature or composition, which delineates life and human activity by means of presenting various actions of dialogues between groups of character (1966: 5).

Drama is the presentation of life and characters thought, action and dialogues words, actions, sceneries, lightings, possibly music and dance all join to make that word within a word that we call theater. Crosby E. Redman explains, "Theater is a play performed in a stage especially designed to enter a make believed word" (1964: 1).

He can experience the play as a conflict, a conflict between himself and another, between circumstances and the other. There are only the dialogues we can create the appearance and personality of the character, their relation of each character and the action that arises from this relationship (David, 1961: 1-2).

One of popular dramas in the Elizabeth period is *Twelfth Night*. That is a romantic comedy, which is regarded by many critics as Shakespeare's most perfect comedy. The play was probably written in 1601 or 1602. According to an entry in John Manningham's diary, it was performed at the middle temple in 1602. *Twelfth Night* appeared in printed form with the first folio of 1623. The title of the play, *Twelfth Night*, indicates the time of the first performance (January 6th,

the twelfth night after Christmas). The subtitle of the play or, What You Will, calls attention to the structure and the character: there is something here for everyone to enjoy. The play is presented on the stage. The conversation in the perform of drama combined with movement and action of a series of incidents that take place in the intercourse of certain person.
