#### **CHAPTER I**

### INTRODUCTION

## 1.1 The Background of the Study

Literature is a part of our lives. Learning literature is a process of understanding the life itself, as literature is the imitation of life. Furthermore, William Henry Hudson strengthens the opinion above in his book, An Introduction to the Study of Literature, that is:

Literature is a vital record of what men have seen in life, what they have experience of it, what they have though and felt about those aspects of it which have the most immediate and enduring interest for all of us.

(Hudson, 1965:10).

#### It means that:

We can see that literature is imagination of our feeling that arises in our lives through our experience to fill our desire. Literature can be as the reflection of our behavior in the past time also as a direction to lead our time in the future.

The writer will talk about literary work that is poetry. Poetry is the oldest literature work, this is proved when we found greatest a literature work that is monumentally written by our ancestor long time ago as, their works were in the form of poetry, for examples; Mahabharata, Ramayana, Bharatayuda, Antigone, form of drama for examples: Oedipus, Hamlet, Macbeth. L.G.Alexander, in their book Poetry and Prose Appreciation for overseas students says that, all of literature work is very interesting to observe but although we found a fantastic poetry and we felt enjoy a poem but it is difficult to fully understand its meaning. It is possible to pay more attention to the way a poet says something rather than to

what he actually has to say, this is saying reading poetry is difficult and makes people lazy to read anymore. Enjoyment however must not be confused with appreciation. Reading poetry means think it over and over. Have reference on dictionary is a must, more over when ones want to understand poetry seriously and to get its beauty. Read the poem as carefully as you can, after that we should be in a position to give its general meaning, its detailed meaning, and to say something about the intentions of the writer.

One way to express our feeling is by means of understanding its art. Art can be formulated variously such as musical art, literature, paintings so forth. It can also appear in poetry. Poem expresses the meaning in simple and obvious manner. It may just tell a story or describe a scene. People do not need to think deeply to understand what the content of the poem is. One poetry contains advice or invitation, because poetry expresses the soul or opinion of poet, where the element of that feeling can not be separated from idea, Christopher Russel Reaske in his book How to analyze poetry says that; when we are enjoyable analyzing poetry we will get a provocative mental and leap of faith with that poetry. Kirkpatrick, Laurance A and Goodfellow, William W, in Poetry with Pleasure, New York, Charles Scribner's Sons, 1968 say that the world of poetry is very interesting to analyze because this part of literary work is a world of wonder. This is a tendency to seek an ideal aesthetic world in fancy and imagination and to express it in individual and sentimental form. Poetry can create happiness, uproar or sadness. This is the cleverness of poet to combine words by words so the

readers join in involving emotion. The writer analyzes two of great poets those are; Robert Burns and Robert Browning. Robert Burns is a poet from Scotland who lived at 18 century. His poetry has the theme of love affair. The majority of Robert Burns Literary works are short and very touching on our feeling, because he is a sensitive man. Robert Browning was a poet from England who lived in 19 century in Victorian Queen Period. He was a dramatic monolog people. From two different generation above, the writer chooses two poems to analyze, those are "A Red, Red Rose", by Robert Burns and "Meeting At Night" by Robert Browning.

The writer is interested in analyzing this topic because the writer has an opinion that all people absolutely have feeling of love or fall in love. Because of love people will get many experiences. This experience leads the writer interested in analyzing the symbol of love in poetry. Literary works are written in several forms, for example; novel, plays, poems, poetry. ### 1.2 Statement of the Problem

### 1.3 Limitation of the Problem

The writer needs to make the scope of the study. The writer makes a limitation about the topic. There are, three types of literature namely, prose, play and poetry. In this thesis analysis the writer would like to choose poetry as the subject of discussion. The writer of this thesis will discuss about the symbol of "Love" because this aspect is reflection of human feelings.
