CHAPTER I

INTRODUCTION

1.1 Background of the Study

Hudson (1965: 10) in *An Introduction to the Study of Literature*:

Kennedy in *An Introduction to Fiction* states that, Novel is a book-length story in prose, whose the author tries to create the sense that while we read, we experienced actual life.
