## **CHAPTER IV**

## CONCLUSION

The objectives of this study, entitled *The Struggles for Sexual Pleasure:*A Feministic Study of the Main Character in D. H. Lawrence's Lady Chatterley's

Lover are (1) to explain Connie's reasons in struggling for sexual pleasure and (2)

to analyze Connie's ways in struggling for sexual pleasure. Library research including Internet browsing is used to formulate the conceptual data of feminism, and related studies. The data corpus of this thesis includes all of the phrases, clauses and sentences, and even discourses, which have relation with feminism of the main character that is found in D. H. Lawrence's Lady Chatterley's Lover. They can be in the form of dialogues, or narratives. Moreover, psycho-social approaches are taken to analyze the data.
