



ABSTRAKSI

Diskriminasi gender terhadap perempuan sering dijumpai dalam kehidupan sosial. Diskriminasi gender tersebut mengacu pada perlakuan-perlakuan tidak adil yang dialami perempuan baik dalam keluarga maupun dalam kehidupan sosial yang lebih luas. Kurang lebih ada tiga efek diskriminasi gender terhadap perempuan. Ketiga efek tersebut adalah marginalisasi perempuan, munculnya kekerasan terhadap perempuan; dan beban tugas dan tanggung jawab yang dirasakan perempuan.

Studi ini mengupas isu diskriminasi gender yang dialami Linda Loman, salah satu tokoh utama dalam drama *Death of A salesman* karya Arthur Miller. Studi ini dimaksudkan untuk menemukan sifat-sifat umum Linda, mengidentifikasi praktek-praktek diskriminasi gender yang dialami oleh Linda, serta mengidentifikasi faktor yang menyebabkan terjadinya diskriminasi gender tersebut.

Dalam melakukan studi ini penulis menggunakan pendekatan gender. Dengan menggunakan pendekatan tersebut, studi ini difokuskan pada isu diskriminasi gender yang dialami oleh Linda Loman. Beberapa teori digunakan untuk mendukung studi ini, antara lain tentang diskriminasi itu sendiri, diskriminasi gender yang mencakup sebab-sebab dan manifestasinya, teori tentang karakter dan karakterisasi.

Studi ini menemukan bahwa Linda Loman sungguh mengalami diskriminasi gender yang dilakukan oleh Willy Loman, suaminya serta Biff dan Happy, kedua anaknya. Linda mengalami keterbatasan akses terhadap kehidupan sosialnya yang luas. Linda hanya melakukan tugas-tugas yang secara umum dianggap sebagai pekerjaan rumah tangga, seperti memasak, mencuci, dan menjahit. Ia tidak diperkenankan melakukan pekerjaan-pekerjaan di luar rumah seperti berbisnis. Willy sering menggunakan kata-kata kasar terhadap Linda. Willy juga berbicara kepada Linda dengan nada membentak dan marah yang menunjukkan superioritas dan otoritasnya. Linda juga disingkirkan dari urusan keluarga, ia tidak diperkenankan terlibat dalam pengambilan keputusan keluarga. Willy bekerja keras untuk menghindari pengaruh Linda terhadap kepribadian kedua anaknya. Willy berusaha menjadikan mereka miliknya sendiri dan meimbangkan mereka dengan filosofinya sendiri. Linda juga mengalami ketidaksetiaan Willy dalam hubungan suami-istri. Diskriminasi gender tersebut disebabkan oleh inferioritas Linda yang termanifestasi dalam sikap-sikapnya yang lemah, rendah diri, dan mendukung semua yang diinginkan dan dikerjakan Willy. Linda tidak pernah mengkritik Willy meskipun Willy sering kali melakukan kesalahan. Linda merasa malu, takut, dan gugup dihadapan Willy. Saat berbicara dengan Willy, Linda tidak pernah menunjukkan kepercayaan diri. Linda menanggapi nada pembicaraan willy dengan menangis.
