CHAPTER I

INTRODUCTION

1.1 Background of the Study

Hudson states in An Introduction to Study of Literature that:

an author as means of understanding his art, and third, can be used to explain fictitious character (1962:71-72).

The psychological approach is applied in this thesis because the writer wants to analyze about the psychological conflict of main character. To keep the discussion on tract, the writer takes the psychological approach according to Freud's psychoanalysis. It concerns the structure of personality that consist of Id, Ego, and Superego.
